

# Fundamental Sewing Course User Agreement

## Welcome to the Fundamental Sewing Course

This User Agreement ("Agreement") governs your use of the Fundamental Sewing Course (the "Online Course", "Course"), provided by Vikisews LLC ("Vikisews", "we", "us", "our"). By enrolling in the Course, creating an account, or otherwise engaging with the Course, you ("User", "you", "your") agree to be bound by the terms and conditions set forth in this Agreement ("Terms"). If you do not agree with any part of these Terms, please do not enroll in or otherwise engage with the Course.

### 1. Course Details

**1.1 Course Content:** The Course consists of pre-recorded video lessons, PDF sewing patterns, and mentor support.

**1.2 Registration:** To enroll in the Course, you must provide your name and email address. Upon purchase, an account will be created for you, and login details will be sent to the email address provided.

**1.3 Access:** You will have lifetime access to the Course materials. In case of full payment, all materials will be released at once after the payment has been received. In case of partial payments, materials will be released once each payment has been received, according to the following schedule:

- **Unit 1:** Introduction – Released after the 1st payment
- **Unit 2:** How to Sew High-Quality Garments – Released after the 1st payment
- **Unit 3:** Bethany Skirt – Released after the 1st payment
- **Unit 4:** Madelaine Dress – Released after the 2nd payment on 23.02.25
- **Unit 5:** Whitney Trousers – Released after the 3rd payment on 23.03.25
- **Unit 6:** Xelia Blouse – Released after the 4th payment on 23.04.25
- **Unit 7:** Ines Blazer – Released after the 5th payment on 23.05.25
- **Unit 8 (Bonus Module):** Released after the 5th payment on 23.05.25

### 2. Payments

**2.1 Payment Options:** You may choose between 4 payment options:

- **Fundamental Sewing course + Mentor Support, Full Payment:** \$390, payable at the time of registration.

- **Fundamental Sewing course + Mentor Support, Installment Plan:** The payment plan consists of a \$90 first payment, followed by \$75 per month for the next four months. In case you choose the installment plan, recurring payments will be applied, and the money will be automatically deducted from the same card used for the initial payment, according to the following schedule:

1st payment of \$90 – from 23.01.2025

2nd payment of \$75 – 23.02.2025

3rd payment of \$75 – 23.03.2025

4th payment of \$75 – 23.04.2025

5th payment of \$75 – 23.05.2025

- **Fundamental Sewing course without Mentor Support, Full Payment:** \$290, payable at the time of registration.
- **Fundamental Sewing course without Mentor Support, Installment Plan:** The payment plan consists of a \$90 first payment, followed by \$50 per month for the next four months. In case you choose the installment plan, recurring payments will be applied, and the money will be automatically deducted from the same card used for the initial payment, according to the following schedule:

1st payment of \$90 – from 23.01.2025

2nd payment of \$50 – 23.02.2025

3rd payment of \$50 – 23.03.2025

4th payment of \$50 – 23.04.2025

5th payment of \$50 – 23.05.2025

### **3. Course Freezing**

**3.1 Freezing Mentor Support:** You may freeze Mentor Support for a period of 1 week, 2 weeks, or 1 month during the duration of the Course. Mentor Support will be extended by the length of the freeze period.

**3.2 Maximum Freeze Period:** The maximum cumulative freeze period allowed during the Course is 1 month.

### **4. Refunds**

**4.1 Refund Policy:** You are entitled to a full refund until February 1st, 2025, without needing to provide a reason.

**4.2 Partial Refunds:** After February 1st, 2025, refunds may be issued proportionally based on the Course content released up to that date.

**5.3 Extended Mentor Support:** After June 23, 2025, you may purchase extended mentor support for the following fees:

- \$35 for 1 month
- \$65 for 2 months
- \$90 for 3 months

The option to buy an extension is available until September 23, 2025.
